SAAC PARENT OR GUARDIAN RELEASE OF LIABILITY and RULES AGREEMENT

SAAC-42 Open Track (herinafter "Event")
June 8-9 2017 Indianapolis Motor Speedway

WHEREAS, (print name) Passenger (hereinafter "Passenger") desires to ride as a Passenger on the track and/or partipate in said Event sponsored by the Shelby American Automobile Club (hereinafter "SAAC"); and

WHEREAS, Parent or Guardian acknowledges that there are certain known and appreciated significant risks, including bodily injury, death and property damage, attendant to and inherent in participation in motorsports events.

NOW, THEREFORE, in consideration of his being permitted to ride in a vehicle at said Event, Parent or Guardian, on behalf of himself, his successors, heirs, assigns, or any other person or entity who may claim by or through Parent or Guardian, hereby releases SAAC, its officers, agents, employees and individual members from any and all claims which might be asserted against any of the aforesaid persons or entities by reason of Parent or Guardian's riding in any vehicle at said Event.

Parent or Guardian hereby releases the aforesaid parties from liability for any injury or injuries Parent or Guardian might sustain to his person or property, by reason of conduct of any person, entity or group, whether by any natural or artificial, foreseeable or unforeseeable cause, or whether by any defect in any vehicle, piece of equipment, facility or building at or near said Event.

Parent or Guardian does agree, by signing this SAAC PARENT OR GUARDIAN RELEASE OF LIABILITY AND RULES AGREEMENT, that he will abide by all the rules and regulations set forth by SAAC, including, but not limited to, the following:

(Initial) 1. Parent or Guardian agrees that he shall be the sole spokesperson for himself and all members in his party pertaining to compliance with the rules and regulations and he agrees and understand that he is responsible for the conduct of all in his party:

(Initial) 2. Parent or Guardian agrees that all decisions of SAAC Officials shall be non-litigable. Parent or Guardian further covenants and agrees that he will not initiate any type of legal action against SAAC to challenge such decisions, to seek monetary damages, to seek injunctive relief or to seek any other kind of legal remedy. Parent or Guardian understands that if he pursues any such legal action, which violates this provision, then he expressly agrees to reimburse SAAC for all of its attorney's fees and costs in defending against such legal action.

(Initial) 3. Parent or Guardian certifies that he is at least 18 years of age.

Parent or Guardian further understands that there is no express or implied warranty of safety by SAAC and takes sole responsibility for any harm to his person or property due to attending said Event or riding in a car during said Event.
